

RANCHO MISSION VIEJO REFERRAL TO RIENDA PROGRAM

REFERRAL ACKNOWLEDGMENT FORM (RAF)

(Effective Date: September 1, 2022)

Congratulations! In connection with your purchase of a new home within Rancho Mission Viejo’s Village of Rienda (“Rienda”), you may be eligible to receive a benefit under the Rancho Mission Viejo Referral to Rienda Program (“Program”).

Pursuant to the Program, RMV PA3 Development, LLC (“Master Developer”) will make a one-time payment of \$1,000.00 to the Rancho Mission Viejo Master Maintenance Corporation (“Rancho MMC”) that will be applied toward your General Assessment association fees IF:

- you were referred to Rienda by an individual (“Referring Party”) who currently owns a home within the Rancho Mission Viejo Planned Community (i.e., any neighborhood located in the Village of Sendero, the Village of Esencia or the Village of Rienda); -AND-
- you enter into a new home purchase contract between September 1, 2022 and August 31, 2023; -AND-
- you successfully close escrow on the purchase of your new home.

And, as an EXTRA BONUS, Master Developer may reward the Referring Party for introducing you to the Village of Rienda. Specifically, if you satisfy the foregoing requirements, and subject to other Program conditions and restrictions, Master Developer will make a one-time payment of \$3,000.00 to Rancho MMC that will be applied toward the Referring Party’s General Assessment association fees.
